



# NORDIC SMASH T20

## SQUAD ELIGIBILITY CRITERIA

SANCTIONED BY THE SWEDEN CRICKET FEDERATION (SCF)

### 1.1 Nordic Smash T20 Squad List

**1.1.1** All players, coaches and managers nominated in a Nordic Smash T20 Franchise squad list must hold valid documentation (travel visa or equivalent approval) for Sweden well in advance of the Franchise's participation in the NORDIC SMASH T20 event.

**1.1.2** All squads must be submitted on the form provided by NORDIC SMASH T20 no later than 30 days before the start of the event, comprising 16 people in total, including 15 players and 1 coach or manager, to represent the Franchise at NORDIC SMASH T20.

**Note:** Deadline for Men's Tournament (start date 15 June 2026): squad list must be submitted no later than 01 June 2026.

If a Franchise does not adhere to the 15-day deadline for submission of the Squad List, then NORDIC SMASH T20, at its sole discretion, may reduce or remove any Franchise payments or Prize Money to be awarded, or may revoke the Franchise's invitation to the event.

**1.1.3** Players nominated in the Franchise squad list are required to have played a minimum of one (1) match for the Franchise in a recognized domestic match in the preceding calendar year (excluding Nordic Smash T20 matches), except for players nominated pursuant to 1.1.4.

**1.1.4** Up to two (2) players are permitted to be nominated in the Franchise squad list who have not played for the Franchise in a recognised domestic match in the previous calendar year, and therefore do not meet the criteria in 1.1.3.

**1.1.4.1** In extenuating circumstances, more than two players who do not fulfil the criteria in 1.1.3 may also be included, but only if express written permission is obtained from NORDIC SMASH T20 in advance.

**1.1.5** Once submitted with the approval of the Franchise's affiliated Federation, the NORDIC SMASH T20 Franchise squad lists will be shared with the Sweden Cricket Federation (SCF) to identify any player who may be registered with multiple Federation domestic league teams simultaneously.

The SCF has a maximum of two (2) weeks to raise any concerns to NORDIC SMASH T20, whereupon NORDIC SMASH T20 will mediate between the Franchise and the SCF to find a solution in the interest of fair play.

**1.1.6** The Franchise squad list will then be further vetted by NORDIC SMASH T20 (for example, in cases of anti-corruption concerns or eligibility risks) within two (2) weeks of being approved by the SCF before being officially accepted. Any players disapproved by NORDIC SMASH T20 must be removed from the squad list, and the Franchise must be informed immediately to arrange a suitable replacement as required.

**1.1.7** For the avoidance of doubt, a player may not represent multiple Franchise teams within the same edition of NORDIC SMASH T20.

**1.1.8** If the Franchise wishes to include more than 18 persons in their squad for the event, they may do so at the Franchise's own expense. Catering at the ground for additional persons may be deducted from the Franchise's Prize Money allocation. Additional players may be selected to play provided they were approved by NORDIC SMASH T20 in accordance with 1.1.6.

1.1.8.1 Franchises may have a maximum of 20 players on their official squad list.

1.1.8.2 The coach or manager may also be listed as a player, provided the total number of listed players does not exceed 20.

## 1.2 Changes to the Squad List for the Knockout Stage

1.2.1 If the Franchise wishes to amend its Squad List for the Knockout Stage of the event, the Franchise must submit any proposed changes to NORDIC SMASH T20 in writing and obtain NORDIC SMASH T20's prior written consent before such changes are confirmed.

1.2.2 For the avoidance of doubt, only players who were included in the Initial Squad List and approved in accordance with 1.1.6 are eligible to participate in Knockout Stage matches.

1.2.3 If the Franchise wishes to bring more than 18 persons to the Knockout Stage, the Franchise may do so at the Franchise's own expense. Catering at the ground for additional persons may be deducted from the Franchise's Prize Money. Additional players must have been approved by NORDIC SMASH T20 on the squad list in accordance with 1.1.6.

## 1.3 Prize Money

1.3.1 For the avoidance of doubt, the NORDIC SMASH T20 Official Invitation document sets out all financial conditions for the event with regard to Prize Money. By participating in the event, the Franchise accepts the invitation and the financial conditions as specified in the Official Invitation.
