TERMS AND CONDITIONS

SANCTIONED BY THE SWEDEN CRICKET FEDERATION (SCF)

Important Notice

By accessing www.nordicsmash.com, purchasing tickets, registering as a player or franchise, or attending any Nordic Smash T20 event, you agree to be bound by these Terms and Conditions. Please read them carefully. If you do not agree, you must not use our services.

1. Definitions

In these Terms and Conditions, the following definitions apply:

- "Nordic Smash T20" / "we" / "us" / "our" refers to the Nordic Smash T20 League and its organisers.
- "User" / "you" refers to any individual accessing the website, purchasing tickets, or attending events.
- "Platform" refers to www.nordicsmash.com and associated mobile/digital services.
- "Event" refers to any match, tournament, or associated function organised by Nordic Smash T20.
- "Player" refers to any registered cricketer participating in the league.
- "Franchise" refers to any team ownership entity participating in the league.

2. Use of the Website

2.1 Permitted Use

You may use our Platform for lawful purposes only. You must not:

- Use the Platform in any way that violates applicable Swedish or international law
- Attempt to gain unauthorised access to any part of our systems or infrastructure
- Transmit any unsolicited commercial communications or malware
- Scrape, reproduce, or redistribute content without our prior written consent
- Impersonate Nordic Smash T20, its staff, players, or partners

2.2 Account Registration

To access certain features (e.g. ticket purchase, live scoring), you may be required to create an account. You are responsible for maintaining the confidentiality of your login credentials and for all activity under your account.

3. Tickets and Attendance

3.1 Ticket Purchase

- All ticket sales are subject to availability and confirmation of payment

- Tickets are non-transferable unless otherwise stated
- Nordic Smash T20 reserves the right to refuse admission at its discretion
- Concession tickets (e.g. children, seniors) may require proof of eligibility at the gate

3.2 Refunds and Cancellations

- If an event is cancelled by Nordic Smash T20, a full refund will be issued to the original payment method
- If an event is postponed, tickets will remain valid for the rescheduled date; refunds will be available upon written request within 14 days
- Tickets purchased are non-refundable for personal reasons or change of circumstances
- In the event of match abandonment due to weather after play has commenced, no refund will be issued

3.3 Venue Rules

All attendees must comply with the rules and regulations of Norsborg Cricket Ground, Stockholm, including:

- No unauthorised filming, recording, or photography for commercial use
- No items prohibited by the venue (weapons, flares, unauthorised banners)
- Intoxicated individuals may be refused entry or removed from the venue
- Children under 12 must be accompanied by a responsible adult at all times

4. Player and Franchise Registration

4.1 Player Eligibility

- Players must be registered and verified through the official Nordic Smash T20 registration process
- All players must hold valid documentation confirming eligibility to participate
- Players are subject to the Nordic Smash T20 and Sweden Cricket Federation (SCF) Playing Conditions and Code of Conduct with players safeguard policies.
- Nordic Smash T20 reserves the right to disqualify any player found to have provided false registration information

4.2 Franchise Obligations

Franchise owners agree to:

- Comply with all Nordic Smash T20 commercial, operational, and governance guidelines
- Bring a minimum of 6 international marquee players per roster
- Actively support sponsorship acquisition and community engagement activities
- Align with the centralised branding and marketing strategy of the league
- Pay all applicable franchise fees and meet financial obligations on time

4.3 Code of Conduct

All players, franchise staff, and officials must conduct themselves in accordance with the Spirit of Cricket. Violations of the Code of Conduct may result in:

- Formal warnings issued by the Tournament Referee
- Suspension from one or more matches
- Disqualification from the tournament
- Referral to the Nordic Smash T20 rules and Sweden Cricket Federation for further disciplinary action

5. Intellectual Property

All intellectual property on the Nordic Smash T20 Platform — including the brand name, logo, tournament name, team names, graphics, video content, and statistical data — is owned by or licensed to Nordic Smash T20.

You must not reproduce, republish, distribute, or commercially exploit any content without our prior written permission. Limited use for personal, non-commercial purposes (e.g. sharing match highlights on personal social media) is permitted provided appropriate attribution is given.

6. Streaming and Broadcasting

- Official livestreams are available on www.nordicasmash.com, YouTube, FanCode, tapmad, Cricheros and Willow
 - Unauthorised recording or rebroadcasting of matches is strictly prohibited
 - Streaming availability may vary by territory due to broadcast rights agreements
 - Nordic Smash T20 is not responsible for third-party platform outages or technical failures

7. Sponsorship and Commercial Partners

Sponsors and commercial partners engaging with Nordic Smash T20 agree that:

- All sponsorship agreements are governed by a separate written contract
 - Sponsors receive category exclusivity and no competing brand within the same category will be engaged simultaneously
 - Brand placement rights are as specified in the respective partnership tier (Platinum / Gold / Silver)
 - Nordic Smash T20 retains final editorial control over all branded content and communications

8.1 Website Availability

We aim to keep our Platform available at all times but do not guarantee uninterrupted access. We reserve the right to suspend, withdraw, or modify any service without notice.

8.2 Accuracy of Information

While we endeavour to ensure information on our Platform is accurate and up to date, we make no warranties regarding completeness, accuracy, or fitness for any particular purpose.

8.3 Limitation of Liability

To the fullest extent permitted by Swedish law, Nordic Smash T20 shall not be liable for:

- Indirect, incidental, or consequential losses arising from use of our services
- Loss of data, revenue, or profits
- Injuries sustained at events (except where caused by our negligence)
- Third-party platform failures (streaming services, payment processors)

Note

Nothing in these Terms limits our liability for death or personal injury caused by our negligence, fraud, or any other liability that cannot be excluded under Swedish law.

9. Privacy

Your use of our Platform is also governed by our Privacy Policy, available at www.nordicasmash.com/privacy-policy. By accepting these Terms, you confirm that you have read and understood how we handle your personal data.

10. Governing Law and Disputes

- These Terms and Conditions are governed by the laws of Sweden
- Any disputes arising from these Terms shall be subject to the exclusive jurisdiction of the Swedish courts
- Nordic Smash T20 will endeavour to resolve disputes amicably before initiating formal legal proceedings
- Franchise disputes relating to competition rules shall first be referred to the Sweden Cricket Federation (SCF)

11. Amendments

Nordic Smash T20 reserves the right to amend these Terms and Conditions at any time. Continued use of our Platform following notification of changes constitutes acceptance of the revised Terms. The 'Effective Date' at the top of this document will reflect the most recent revision.
